Executive Summary

BOWIE is a culture-first SPL token on Solana designed to fund art, events, and community infrastructure while experimenting with transparent, sovereign-aligned economic structures.

Key Characteristics

- **Utility-Focused:** Medium of exchange for events, creative work, and community contributions
- **Culture-First:** Rewards creativity and courage, not speculation
- **Transparent Governance:** Public documentation, multisig treasury control, locked token supply

- **Anti-Rug Design:** Revoked mint/freeze authority, time-locked allocations, public wallet mapping
- **Community-Driven:** Evolving from stewardship → multisig → DAO experimentation

Core Commitments

1. **No Financial Promises:** BOWIE is not marketed as an investment
2. **Full Transparency:** All major treasury actions documented and public
3. **Responsible Token Management:** Up to 60% of supply locked with public verification
4. **Security-First:** Hardware wallets, multisig control, no seed phrase sharing
5. **Cultural Mission:** Funding real-world experiences, art, and community

Governance Model

BOWIE governance evolves through three phases:

Phase 1: Stewardship (Current)

Purpose: Establish foundation, ensure safety, create documentation

Structure:

- One primary steward coordinates initial decisions
- Focus on treasury organization, documentation, risk reduction
- No large unilateral treasury moves without written rationale
- All decisions publicly documented

Duration: Until multisig infrastructure is operational

Phase 2: Multisig (Next Stage)

Purpose: Distributed control, enhanced security, transparent decision-making

Structure:

- **3-of-5 multisig** controls treasury (Squads Protocol or equivalent)
- Tiered approval system based on spend amount:
 - < **\$500**: Steward or Ops Lead approval, publicly logged
 - **\$500–\$5,000**: 2-of-5 multisig approval required
 - > **\$5,000**: 3-of-5 multisig approval + public report

Key Features:

- No single key controls treasury
- All proposals documented before execution
- Public transaction logs for significant spends
- Hardware wallets for signers where possible

Phase 3: Community Governance (Future)

Purpose: Broader participation, DAO experimentation, community input

Structure (evolving):

- Community proposals from active contributors
- On-chain or off-chain voting (pending legal review)
- Input on budgets, grants, strategic direction
- Formal governance framework and tools

Principles:

- Documented
- Transparent
- Adaptable
- Legally compliant

Treasury Management

Treasury Purpose

The BOWIE Treasury exists to:

1. Secure long-term cultural and economic stability
2. Fund creative, community, and infrastructure initiatives
3. Provide transparent, accountable stewardship of shared resources
4. Demonstrate responsible, sovereign-aligned financial governance

The treasury is not a speculative pool for private gain. It is a commons intended to support culture, art, community, and experimentation.

Three-Wallet Architecture

1. Treasury Vault (Long-Term Reserve)

- **Purpose:** Strategic initiatives, major grants, long-term development
- **Control:** Highest level of governance protection (multisig)
- **Usage:** Rare, large, well-documented movements only

2. Operations Wallet

- **Purpose:** Day-to-day operational costs
- **Control:** Refilled from Treasury Vault under strict rules
- **Usage:** Small, controlled expenditures (hosting, tools, small bounties)

3. Liquidity Wallet

- **Purpose:** Market liquidity provision
- **Control:** Multisig with specialized parameters
- **Usage:** AMM pools, LP adjustments, liquidity maintenance
- **Prohibition:** Never used for operational or personal spending

Separation ensures clarity, accountability, and anti-rug credibility.

Authorized Uses of Treasury Funds

Cultural Initiatives

- Art installations and exhibitions

- Events and gatherings
- Creative commissions and residencies
- Educational or cultural workshops

Infrastructure

- Website and technical infrastructure
- Multisig and security tooling
- Developer and contributor bounties
- Legal and compliance support

Community Growth

- Community rewards and airdrops
- Bounties for moderation, content, contributions
- Marketing aligned with culture (not hype manipulation)

Long-Term Capital Management

- Reserve diversification (SOL, stablecoins)
- Liquidity maintenance and rebalancing

Explicit Prohibitions

The treasury **may not** be used for:

✗ Personal enrichment of any single founder or signer ✗ Coordinated pumps, buy bots, or market manipulation
✗ Wash trading or artificial volume ✗ Bribes, coercion, or secret payoffs ✗ Private debt repayment of individuals ✗ Unauthorized "emergency withdrawals" without documentation

Any breach triggers governance review and potential removal of signers.

Transparency Rules

Public disclosure of:

1. **Treasury Addresses:** All wallet addresses with Solscan/SolanaFM links
2. **Monthly Summaries:** Inflows, outflows, and balance changes
3. **Transaction Logs:** Documentation for all significant spends
4. **Governance Decisions:** Rationales for major treasury actions
5. **Budget Proposals:** Pre-funding plans and post-mortems for initiatives

Governance repository (GitHub) stores all policies, logs, and documentation.

Technical Architecture

Blockchain & Token

- **Chain:** Solana
- **Token Standard:** SPL Token

- **Key Security Features:**

- Mint authority revoked (planned, with public proof)
- Freeze authority revoked (planned, with public proof)
- Transparent supply and distribution
- Immutable total supply


Multisig Infrastructure

- **Platform:** Squads Protocol (or equivalent industry-standard solution)
- **Configuration:** 3-of-5 signature requirement for treasury operations
- **Signer Security:** Hardware wallets (Ledger) recommended for all signers
- **No Seed Phrase Sharing:** Absolute prohibition, zero exceptions

Time-Lock Implementation

- **Service:** SolanaTimeLock (recommended), Team Finance Solana Locker, or SolanaLocker
- **Verification:** All locks generate public vault addresses and transaction hashes
- **Transparency:** Lock certificates published in documentation and governance repo

- **Repository:** GitHub for governance documentation
- **Multisig:** Squads Protocol

Security & Anti-Rug Measures

BOWIE implements comprehensive security measures to prevent rug pulls and ensure long-term credibility.

1. Revoked Authorities

✓ Mint Authority Revoked No additional tokens can be created after revocation. Transaction proof made public.

✓ Freeze Authority Revoked No ability to freeze or disable user wallets. Transaction proof made public.

Result: Total supply becomes permanently fixed and immutable.

2. Time-Locked Supply

✓ Up to 60% of supply locked with public verification **✓ Lock durations:** 6–24 months depending on category **✓ LP tokens locked:** 9–12 months (strongest anti-rug signal) **✓ Public vault addresses:** All locks verifiable on-chain **✓ No early unlock:** Locks are final and irreversible by design

3. Multisig Treasury Control

✓ 3-of-5 multisig prevents unilateral control **✓ No single key** can access treasury funds **✓ Tiered approvals** based on spend amount **✓ Public documentation** for all significant transactions

4. Operational Security

✓ Hardware wallets for all signers (recommended) **✓ No seed phrase sharing** (absolute prohibition) **✓ Public wallet mapping** for community audit **✓ Regular security reviews** and external audits (planned)

5. Transparency Commitment

✓ All treasury addresses public **✓ Monthly financial reports** **✓ Transaction logs for major spends** **✓ Governance decisions documented** **✓ Budget proposals and post-mortems**

Security Recommendations for Participants

When interacting with BOWIE:

- Verify token mint address on multiple sources
- Use hardware wallets for significant holdings
- Never share seed phrases or private keys
- Verify all official communications through multiple channels
- Review all lock certificates and vault addresses independently
- Participate in governance discussions and oversight

Emergency Procedures

If you mistakenly lock tokens:

- There is **no early unlock** mechanism
- Tokens remain inaccessible until the specified unlock date
- Contact lock service only for UI/technical errors

Locks are final by design to ensure credibility and prevent manipulation.

Roadmap

BOWIE's development follows a phased, adaptive approach.

Phase 1: Foundation (Current)

- First small cultural grants and experiments

Deliverables:

- Operational 3-of-5 multisig
- Public wallet mapping
- Lock certificates and vault addresses
- Initial grant recipients and case studies

Phase 3: Expansion (Q2-Q3 2026)

Goals:

- Merchant acceptance pilots (venues, events, creators)
- Recurring BOWIE-linked events and gatherings
- Contributor and bounty programs
- Community growth initiatives

- Documentation site launch

Deliverables:

- 3+ merchant acceptance partnerships
- Quarterly cultural events
- Active contributor community
- Public-facing documentation site

Phase 4: Governance Evolution (Q4 2026+)

Goals:

- Community proposal mechanisms
- DAO / governance tooling experiments
- Ongoing refinement of treasury rules
- Expanded multisig or governance structures
- Long-term sustainability model

Deliverables:

- Community governance framework
- Proposal and voting infrastructure
- Formal DAO structure (if legally viable)
- Multi-year treasury sustainability plan

Cultural Philosophy
